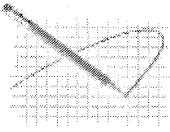

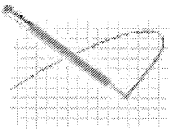

**Re; Te Roroa Settlement Bill**

Dear Prime Minister,

It has been rumoured that the Government is about to pass the Te Roroa Settlement Bill. **This would be a very silly move until a full public inquiry is held.**

Te Roroa are not happy with the Bill and the Solicitor General has stated, "There was an error or errors in the handling of the documents (to acquire Mr Titford's properties) at the time".

The Ombudsman finding in her investigation, memorandums were deliberately removed from the Sale Agreement after Mr Titford had signed and had it witnessed, making the Sale Agreement "legally" null and void. The Crown also has no "legal" documents to over-rule the 1876 Deed of Conveyance when this land passed to the Crown.

The Crown, the Waitangi Tribunal or the claimants have also been unable to supply one documents to substantiate this claim.

Prime Minister, this claim will never go away, it is now fully documented on our websites and many international websites around the world.

**It is a fraudulent claim and the Sale Agreement to acquire Mr Titford's properties was corrupt.**

To pass the Bill without a full public investigation just adds fuel to the fire. Te Roroa are not happy with it and we will not give up - ever!!!

**It is corrupt, corrupt , corrupt!!!**

I have attached our latest letter to the Solicitor General, which appears on our website. We have documented evidence to substantiate our claims in this letter.

As it seems the Solicitor General, Dr David Collins, QC is not going to hold a Judicial Review into the "deliberate errors" into the handling of the documents by the Crown Law Office for very obvious reasons, therefore as Prime Minister, you have a duty to the people of New Zealand to hold a full public inquiry, not only into the claim but the "**corrupt**" handling of the Sale Agreement by the Crown Law Office's officials after Mr Titford had signed and had the Sale Agreement witnessed. A fact found by the Ombudsman's investigation. All this is fully documented on our website, plus many others - worldwide!!!


**Without a full public inquiry, the New Zealand Government, under Labour, is seen world wide to be corrupt!!!**
